Cultural Policy of the City of Novi Sad: Eđšeg Castle

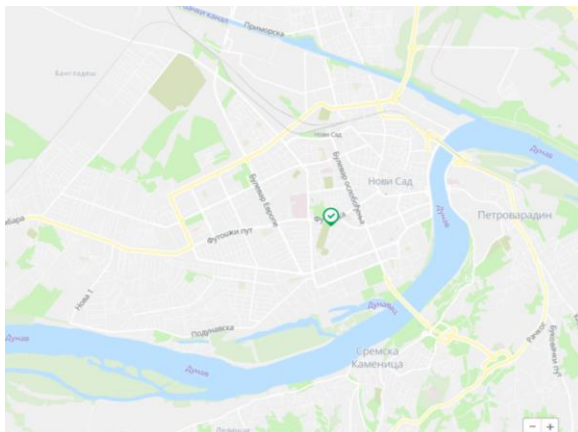
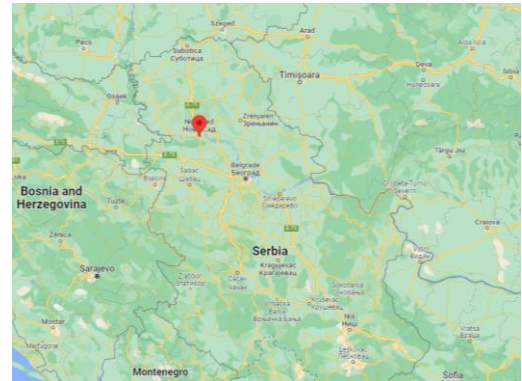

✚ **Description**



The cultural station building was built in 1890 by the “Novi Sad Shooting Association” on the centenary of its founding. It is the work of György Molnár, the creator of the Novi Sad Town Hall. It was built in an eclectic style typical of the end of the 19th century. The main hall is richly decorated, while the ceiling is painted with scenes from hunting and village life intertwined with geometric and floral motifs. After decades of decay, it was renovated in 2012 for the cultural needs of the city, but was rarely used. In September 2018, it was handed over to the management of the “Novi Sad – European Capital of Culture’ Foundation”, implementing new European models and a strategy of creative places for the local community. Now, Eđeg is open to citizens and the cultural scene under the slogan “family castle”, offering

wide range of programmes for families with children and senior citizens. The programmes are mostly produced by local active artists and NGOs, but also European artists coming to the city throughout Novi Sad 2021 mobility projects (from the website of the Tourist Organization of the City of Novi Sad,
